goetzpartners advised Mid Europa Partners and Wheelabrator/DISA on the sale of European heavy duty wheelblast assets

On April 30th, the Wheelabrator/DISA Group, owned by Mid Europa Partners, completed the sale of its three subsidiaries Berger Strahltechnik GmbH, WG Technology S.r.l. (Italy), and V+S Vogel & Schemmann Maschinen GmbH, (a shot blast operation of DISA Industrieanlagen GmbH) to CER Europe Holdings LLC. CER Europe Holdings, a portfolio company of US-based private equity firm Atlas Holdings LLC, is the holding company of US blast equipment vendor Pangborn Corporation. The value of the transaction was not disclosed.

With almost 2,000 wheelblast machines installed globally, the three entities form one of the leading providers of heavy duty wheelblast applications, primarily to the foundry, forge and automotive industries. The sale of the three companies was mandated by the German Federal Cartel Office (FCO) in August 2008.
