On December 7<sup>th</sup>, 2009, EuroMaint Rail AB ("EuroMaint Rail"), a subsidiary of EuroMaint AB ("Euro-Maint"), entered into an agreement to acquire RSM Rail Service Management GmbH and its group companies (jointly "RSM Group") from its current shareholder, Hermann Weise, for an undisclosed consideration. The transaction is subject to approval of the respective cartel authorities.

The share of private maintenance service providers in the German railway freight traffic market is increasingly growing. RSM Group has built up a leading position in this market over recent years by focusing on the maintenance of privately owned freight-related rolling stock.

The acquisition of RSM Group enables EuroMaint Rail to expand its pan-European offering with an extensive network of technically qualified maintenance workshops.
